**MISCELLANEOUS:**

1. For hazardous/Reefer/Tank containers the Terminal Handling Charges and Terminal Service Charges are 50% more than the normal tariff.
2. For ODC consignments the rates are 50% more than the normal Terminal Handling Charges and Terminal Service Charges.

3. Cargo handling activities are not part of any tariff and shall be provided on need basis on separate charges:

- **Terminal Stuffing:** Shall include unloading break-bulk domestic cargo (handled by either labour/3 tonne forklifts only) from Consignor's transport and stuffing it in nominated container; It includes Cargo Stuffing – Labour and Mechanical.
- **Terminal Destuffing** Shall include destuffing of cargo from Containers (handled by either labour / 3 tonne Forklifts) & Loading break-bulk cargo (handled by either labour/3 tonne forklifts only) to consignee's vehicle. It includes Cargo Stuffing – Labour and Mechanical

The charges for stuffing/destuffing of container shall be (Including 3MT Forklift)

20' Rs 1750/-

40' Rs 3500/-

4. Specific crane charges or 5 Ton Fork Lift for undertaking special activities are not part of any tariff and shall be provide on need basis on separate charges.
5. Stabling charges (after the free time of 24 hrs from the date and time of arrival) at the rate of Rs. 50,000/- per rake per day or part there of.
6. TAC of Empty Flat Rake shall be charged @ Rs. 54000/- per Rake or Rs. 1200/- per Empty Flat Wagons.
